# **RULES GOVERNING YOUTH CHAMPIONSHIP CONTESTS**

**Applicable Rules.** All WPBF sanctioned youth championship contests, which will be governed by the WPBF Rules and Regulations, and the WPBF Championship Rules. In the event of a dispute regarding the rules, guidelines or any other issue that is not clearly covered in the following rules, the supervising commission of the bout will be the final authority.

**Violations.** Any violation of the WPBF Rules & Regulations would ordinarily be cause for disqualification and/or withdrawal or suspension or other disciplinary action. A copy of the Rules & Regulations will be provided by the WPBF Supervisor at Rules Meeting, the Boxers or their authorized representatives will sign these rules, no party can claim lack of knowledge of the WPBF Rules and Regulations, as they are posted on the WPBF's official website <u>WWW.WPBF-USBC.COM</u>

#### Item - 4

Both boxers must be present in the dressing rooms at the bout venue at least two (2) hours before the start of the bout, that is \_\_\_\_\_\_o'clock and the bout will start at \_\_\_\_\_o'clock. Only the WPBF Supervisor, local commissioner, ringside physician and referee will be allowed in the dressing rooms before the bout. Unless approved by the local boxing commission, no any spectator, Journalist or any other unauthorized person will be allowed in the dressing rooms before the bout.

# 1. GENERAL RULES AND REGULATIONS

- **1.1** All the Youth Championship Contests recognized by the WPBF shall be scheduled for ten (10) rounds, each round three (3) minutes in duration with a one (1) minute rest period between rounds.
- **1.2** The referee is the sole arbiter of a bout and is the only individual authorized to stop a contest.
- **1.3** All bouts shall be evaluated and scored by three (3) judges.
- 1.4 The 10 Point Must System shall be the standard system of scoring a bout.
- **1.5** The Mandatory Eight (8) Count after knockdowns will be standard procedure in all bouts.
- 1.6 All professional boxers are required to wear a mouthpiece during competition. The round cannot begin without the mouthpiece. If the mouthpiece is dislodged during competition, the referee will call time and have the mouthpiece replaced at the first opportune moment, without interfering with the immediate action. Points may be deducted by the referee if he feels the mouthpiece is being purposely spit out.
- 1.7 There is NO Standing Eight (8) Count.
- 1.8 There is <u>NO Three (3) Knockdown Rule</u>.
- **1.9** A boxer shall receive a twenty (20) second count if the boxer is knocked out of the ring and onto the floor. The boxer is to be unassisted by spectators or his/her seconds. If assisted by anyone, the boxer may lose points or be disqualified with such a decision being within the sole discretion of the referee.
- 1.10 A boxer who has been knocked down cannot be saved by the bell in any round.
- **1.11** If a boxer sustains an injury from a fair blow and the injury is severe enough to terminate the bout, the injured boxer shall lose by TKO.

- **1.12** The scorecards will be picked up after the end of each rounds, the official scorekeeper shall tally the score by rounds on a score sheet.
- **1.13** A Champion must defend his title within specified time periods provided in Article 6 of the Rules and Regulations of the WPBF.

# 2. WEIGHT & WEIGH-IN CEREMONIES

- 2.1 Timing of Initial Weigh-In. The official weigh-in shall be no less than twenty (20) nor more than twenty four (24) hours before the scheduled start time of the bout. The scales to be used at the official weigh-in must be available to both boxers at least two (2) hours prior to the official weigh-in.
- 2.2 Weight Determines the Championship. If either or both contestants fail to make the prescribed weight at the prearranged time for the official weigh-in, either or both of them shall have two (2) additional hours to make the prescribed weight.
- **2.3 Champion's Failure to Make Weight.** If a Champion fails to make the prescribed weight, after the two (2) additional hours, the title shall be forfeited on the scale, but the bout may still continue take place as a twelve (12) rounds fight for the vacant title. If the Challenger having made the prescribed weight and wins the bout, the Challenger shall be declared the winner of the vacant title, but if the overweight champion wins the bout, the title shall remain vacant.
- **2.4 Challenger's Failure to Make Weight.** If the Champion makes the prescribed weight and the Challenger fail to do so, the Champion shall retain the title, whether wins or loses the bout.
- 2.5 Failure to Make Weight for Vacant Title or Elimination Bout. If a contestant fail to make the prescribed weight in a fight for a vacant title or elimination bout, the bout may continue take place as a vacant title or elimination bout at the discretion of the WPBF supervisor. If a contestant who makes the weight defeats another contestant who did not make the weight, he shall be declared the winner of the vacant title or the elimination bout.
- **2.6 Both Boxers Failure to Make Weight.** If both the contestants fail to make the prescribed weight in a fight for a vacant title or elimination bout, the sanction of the bout will be withdrawn.
- **2.7 Weigh-ins For Postponement.** If a sanctioned bout is postponed more than 48 hours, a new weigh-in shall be necessary.

# 3. PHYSICAL EXAMINATIONS

**3.1** In order to protect the safety and health of the boxers who participate in the said WPBF sanctioned championship contest, each boxer must pass a pre-bout physical examination by the physician of the local commission. If the event physician's certification fails to certify that the

boxer is physically fit to safely fight, the boxer shall not participate in the said WPBF sanctioned championship contest. The WPBF encourages that each local commission to consider the use of WPBF Medical and Safety Guidelines.

# 4. AGE LIMIT

**4.1** In order to protect the safety and health of the boxers, all youth boxers must be between the ages of 18 to 23 years old and possess a current ID card, along with a birth certificate, in order to compete in a youth championship contest.

# 5. INSURANCE

5.1 Each boxer shall be covered by the minimum amount of medical and life insurance that provides medical coverage for any injuries sustained during a WPBF sanctioned bout, and life insurance payable to the boxer's beneficiary in case of accidental death resulting from injuries sustained during a WPBF sanctioned bout. The Promoter must submit proof of insurance coverage to the local boxing commission for the verification that medical and life insurance have been obtained for each boxer no later than 4 days prior to the bout. The WPBF and USBC shall have no responsibility or liability, whatsoever, for any consequence or outcome resulting from compliance or non-compliance of these rules by the promoter, boxer, managers, trainers or local commission.

# 6. Knockdown and Knockout

- **6.1** A boxer shall be deemed to be down when any part of his body, except his feet are on the ring floor, or if he is still rising from the down position and not standing upright, or if he is hanging helplessly over the ropes as a result of a legal blow as ruled by the referee, who is the only person authorized to determine this.
- **6.2** The Mandatory Eight (8) Count after knockdowns will be standard procedure in any WPBF sanctioned bout, there is no standing eight (8) count, three (3) knockdowns in any one round do not automatically terminate the fight. If in the referee's judgment, which must be keen and decisive, the knockdowns have been indecisive and clearly have no injurious effect upon the boxer, the contest may continue but with good sense and judgment and the boxer's welfare always paramount.
- **6.3** When a boxer is knocked down, the referee shall audibly announce the count as he motions with his right arm downward indicating the end of each second of the count. If the boxer taking the count is still down when the referee calls the count of ten (10) the referee shall wave both arms indicate that the boxer has been knocked out.
- **6.4** When a boxer has been knocked down, the referee shall promptly order the opponent to the farthest neutral corner. If the opponent refuses to remain in the farthest neutral corner as direct by the referee, the referee shall discontinue the count and order his opponent back into the indicated

corner, and then, the referee shall resume the count from the point at which it was interrupted.

- **6.5** A boxer who has fallen through the ropes and onto the floor as a result of a legal blow during the contest may not be assisted by anyone, and the referee shall start the count, which in this special case will be twenty (20) seconds. If the boxer assisted by anyone, the boxer may lose points or be disqualified with such a decision being within the sole discretion of the referee. If the boxer fails to re-enter the ring before the count of twenty (20) seconds, the referee shall wave both arms to indicate that the boxer has been knocked out.
- **6.6** The bell will not save a boxer in any round. If a boxer is "downed" just before the 3-minute bell in any round, the timekeeper shall not ring the bell, the referee shall continue the count until the contestant rises or is counted out.

# 7. ILLEGAL BLOWS AND FOULS

- 7.1 It is expressly understood that the championship contest will not be terminated by a low blow. The protector that must be used by both contestants is sufficient protection to withstand any so-called low blow.
- **7.2** If one of the boxers shall fall to the ring floor or otherwise indicate an unwillingness to continue because of a low-blow foul, the contest will be terminated and the referee will award the contest to the opponent.
- 7.3 In the case of an accidental foul as determined by the referee, he shall determine if the boxer who has been fouled can continue or not. If his chances have not been seriously jeopardized as a result of a foul, the referee may order the bout to continue after an interval of not more than five (5) minutes.
- **7.4** Any boxers intentional delivers illegal blows to his opponent during a contest will be penalized with loss of points or disqualification, depending upon the severity of the foul and the effect upon the opponent, subject to the referee's discretion.

# 8. INJURIES (CUTS) SUSTAINED BY FOULS

**8.1 Fair Blows.** If a boxer sustains an injury from a fair blow and the injury is severe enough to terminate the bout, the injured boxer shall lose by TKO (Technical Knockout).

### 8.2 Intentional Fouls:

a) If an intentional foul causes an injury, and the injury is severe enough to terminate the bout immediately, the boxer causing the injury shall lose by Disqualification.

- b) If an intentional foul causes an injury, and the bout is allowed to continue, the referee shall notify the authorities and deduct two (2) points from the boxer who caused the foul. Point deductions for intentional fouls will be mandatory.
- c) If an intentional foul causes an injury and the injury results in the bout being stopped in a later round, the injured boxer will win by <u>TECHNICAL DECISION</u> if he is ahead on the score cards; and the bout will result in a <u>TECHNICAL DRAW</u> if the injured boxer is behind or even on the score cards.
- d) If the boxer injures himself while attempting to intentionally foul his opponent, the referee will not take any action in his favor, and this injury shall be the same as one produced by a fair blow.
- e) If the referee feels that a boxer has conducted himself in an unsportsman-like manner, the referee may stop the bout and disqualify the boxer.

#### 8.3 Accidental Fouls:

- a) If an accidental foul causes an injury severe enough for the referee to stop the bout immediately, the bout will result in a <u>NO DECISION</u> if stopped before four (4) completed rounds. Four (4) rounds are complete when the bell rings signifying the end of the fourth round.
- b) If an accidental foul causes an injury severe for the referee to stop the bout immediately after four (4) rounds have occurred, the bout will result in a <u>TECHNICAL DECISION</u> awarded to the boxer who is ahead on the score cards at the time the bout is stopped.
- c) Partial or incomplete rounds will be scored. If no action has occurred, the round should be scored as an even round. This is at the discretion of the judges.
- d) A boxer who is hit with an accidental low blow must continue after a reasonable amount of time but no more than five (5) minutes, or he will lose the fight.

# 9. <u>RINGSIDE PHYSICIANS</u>

9.1 There shall be at least two (2) ringside physicians at ringside at all times, the ringside Physicians shall be seated as close as possible to the corners where the boxers sit between rounds. The ringside physician may enter the ring to examine a boxer's injury when asked by the Referee to do so and may advise his opinion on the injury to the Referee.

# 10. <u>REFEREE</u>

- **10.1** The referee shall be the only person authorized to enforce all the WPBF championship rules that apply to the execution of performance and the conduct of boxers' seconds while he/she is in the ring.
- **10.2** The referee shall be the only person authorized to maintain control of the fight at all stages and issue cautions and/or deduct points as appropriate.
- **10.3** The referee shall be the only person authorized to determine if injuries were the result of legal blows, accidental fouls or intentional fouls.
- **10.4** The referee may interrupt the bout to consult the ringside physician to determine if the injured boxer can continue or not. The referee is the only person permitted to signal the end of a bout.
- 10.5 The referee shall have the power to stop a bout and render a decision at any stage if he considers it to be one-sided or if either boxer in the referee opinion is in such condition that to continue might subject them to serious injury.

# 11. <u>SECOND</u>

11.1. Each Boxer participating in the WPBF sanctioned championship contest shall be allowed not more than four (4) seconds, one inside the ring, two on the ring apron, and one at ground level. One of seconds shall be designated as Chief Second shall be responsible for the conduct of the corner during the fight. No second may enter the ring to assist or move a boxer who has been knocked-down or injured, unless instructed to do so by ringside physicians, or the bell has rung or the bout has been terminated by the referee. A boxer may lose points or be disqualified for the conduct of his chief second or corner.

# 12. WEIGHT OF GLOVES

12.1 The weight of the gloves to be used in the said WPBF sanctioned championship contest shall be based on the weight division of sanctioned contests, as follows:
Eight (8) Ounce gloves shall be used for the Minimumweight up to Welterweight division;
Ten (10) Ounce gloves shall be used for the Super Welterweight up to Heavyweight division.

# 13. BANDAGES

**13.1** In all weight division the bandages shall be restricted to no more than twelve (12) yards of soft gauze, no more than two (2) inches wide. The gauze shall be held in place by no more than eight (8) feet of adhesive tape, no more than one and one (1) inch wide for each hand. The adhesive tape shall not cover any part of the knuckles when the hand is clenched to make a fist. The use of water or any other liquid or material on the tape is strictly prohibited. The Bandages shall be applied in the dressing room in the presence of an inspector and if requested, an opponent's representative. The each boxer's bandages shall be signed by the inspector of local commission.

# 14. PROTECTIVE EQUIPMENT

14.1 The use of a mouthpiece and groin protectors is compulsory for all boxers participating in the said WPBF sanctioned championship contest. All boxers must be prepared two (2) mouthpieces at the start of the bout, the round cannot begin without the mouthpiece. When a boxer loses his mouthpiece during a round, the Referee will call time and have another clean mouthpiece replaced at the first opportune moment, without interfering with the immediate action. Points may be deducted by the referee if the Referee feels the mouthpiece is being purposely spit out.

# 15. DRUGS AND STIMULANTS

- **15.1** The use of prohibited drugs, stimulants either before or during a bout to or by any boxer is absolutely prohibited. Any of the contestants violating this rule shall be subject to disqualification. Any substance other than plain water or an electrolyte solution approved by the ringside physician shall be given to a contestant during the course of a bout is absolutely prohibited. The discretional use of Vaseline around the eyes is permitted, however, the use of Vaseline, grease or any other substance on the arms, legs and body is prohibited.
- **15.2** The use of coagulants, such as Adrenaline 1/1000, Avitene or Thrombin shall be allowed between rounds to stop the bleeding of minor cuts and lacerations sustained by a contestant. The use of "iron type" coagulants, such as Monsel's solution is absolutely prohibited, and the use of such coagulants to or by any contestant shall be considered a violation and shall be cause for immediate disqualification.
- **15.3** In the said WPBF sanctioned championship contest, the Anti-Doping Tests must be mandatory, each boxer is required to take a urinalysis before and/or after the fight. The specimen must be taken with a ringside physician and commission inspector on hand. The specimens should be taken in a plastic container and clearly marked by the physician and boxer.

# 16. RELEASE AND WAIVER OF LIABILITY

The Boxer fully recognize and acknowledge the inherent risks involved with the contests of professional boxing, the Boxer further expressly understands by participating in the said sanctioned event that the Boxers are engaging in an abnormally dangerous activity. The Boxer's participation may suffer a risk of severe injury, damage or death, the Boxer, with full knowledge of this risk, nonetheless, the Boxer freely and voluntarily agree to participate in the said sanctioned event, and the Boxer freely and voluntarily agree to waive and relinquish any and all claims, actions, suits, procedures, costs, expenses, damages and liabilities of any kind or nature that the Boxer or Boxer's heirs, executors, administrators or assignees may have, or claim to have, against the WPBF or USBC and its owners, officers, directors, representative, employees and agents as the result of any injury, damage or death,

resulting from Boxer's participation in the said sanctioned event or arising from traveling to and returning from said sanctioned event.

I (We), the **undersigned**, fully recognize and acknowledge the inherent risks involved with the said sanctioned event, and I hereby freely and voluntarily agree to assume all risk of any personal injury, damage or death that I may suffer as a result of participation in the said sanctioned event. I hereby freely and voluntarily agree to waive and relinquish any and all claims, actions, suits, procedures, costs, expenses, damages and liabilities of any kind against the WPBF or USBC, and its owners, officers, directors, representative, employees, agents.

I (We), the undersigned, hereby agree to indemnify and hold harmless the WPBF and USBC, its owners, officers, directors, representative, employees and agents, from any and all claims and liability, actions, suits, procedures, costs, expenses, damages and liabilities of any kind or nature for any personal injury, damage or death to any third party, resulting from my activities and my participation in the said sanctioned event.

I (We), the undersigned, hereby acknowledge that I have carefully read and fully understand the aforementioned terms, and all of my questions have been answered to my satisfaction, I hereby agrees to respect and adhere to the WPBF and USBC's Constitution, Bylaws, Code of Ethics, the Rules and Regulations and the General Rules for governing championship contests, freely and voluntarily with complete understanding and knowledge of its significance.
